Adjourn: 10:15 p.m.

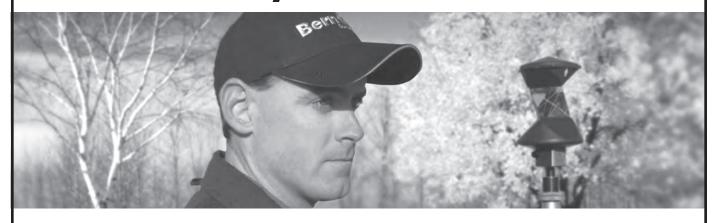
SWC/PLSC

M E M B E R O P I N I O N S A Member's Perspective PLSC Legislative Committee 2006

The Legislative Committee met five times during 2006 to propose and discuss legislation for the 2007 session. Meetings were held at Ackerman Information Corporation office, 1453 Downing, Denver. Some members participated via telephone conference.

Propositions presented, in summary form and in CRS (Colorado Revised Statutes) order, for the 2007 legislative session are as follows:

12-205-201: Proposed amendment would allow surveyors to work in any town, city, county or special service district. In addition, it would limit the agencies from imposing non-statutory survey requirements.

12-205-207(1)(d): Proposal would reenact the requirement for AES Board (State Board of Licensure for Architects, Professional Engineers and Professional Land Surveyors) to publish a printed annual roster and to mail a copy to each registered (licensed) professional.

12-205-208(1)(b): Proposed amendment would prevent AES from accepting a complaint based upon disputed boundary evidence evaluation. In Dexter Brinker's words: "A lawyer is not disbarred or disciplined because he loses a case. Surveyors should enjoy the same privilege."

12-205-209(4): Proposed amendment would remove "administrative law judges" from the disciplinary hearing process." It is reasonable to assume that most administrative law judges know little about surveys and surveyors." -Dexter Brinker.

12-25-218: Proposal would

repeal this section. Currently, 12-25-218 provisions grant AES Board members, witnesses, complainants or designees immunity from any civil or criminal liability resulting from their actions. It is reasonably argued an accused person should be allowed redress from any harm caused by his accusers.

38-44-112: Proposals include wording to make the public's law "boundary agreements," subject to survey laws and regulations.

38-51-102(2.5): Proposed new section would define "Basic Control for Engineering Projects."

38-51-102(5.5): Proposed new section would define "boundary."

38-51-102(7.4): Proposed new section would define "Geodetic Sur-

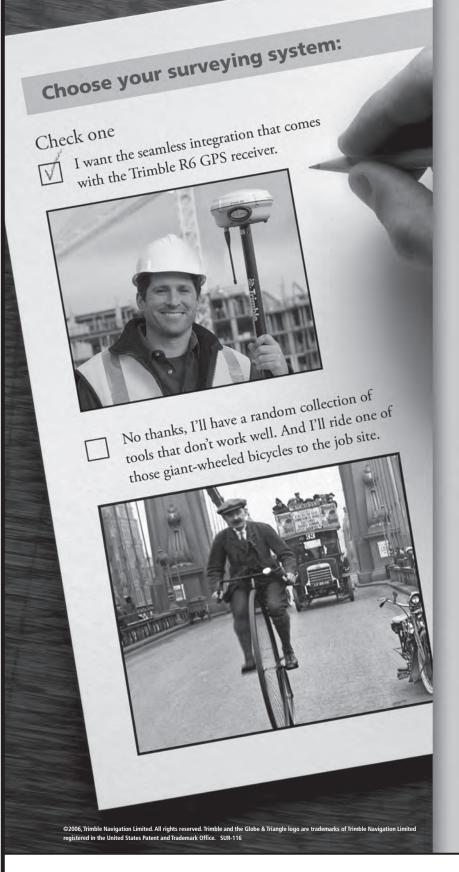

veying."

38-51-102(12): Proposal would change wording for Land Survey Plat definition.

38-51-102(12.3): Proposed amendment would remove the redundant word "point" from the monument definition.

38-51-104(5)(a) and (b): Proposed repeal would eliminate statutory requirements to place monuments:

(a) one-half foot below paved surfaces.

(b) in monument box. 38-51-106(1)(c): Proposed amendment would require both field measurements and non-measured dimensions to be shown on plats and that non-measured dimensions be clearly indicated.

38-51-106(1)(I): Proposed new section would require a plat statement indicating survey lineal units used.

38-52: Proposal would repeal Colorado Coordinate System article. State plane coordinates were established for highway purposes (North Carolina) in 1933 and later adapted for surveys. Today and in the future, because of new algorithms, projections, and technology, surveyors have and will have available superior methods for working with positional parameters.

Other proposals included possible solutions to problems created when subdivision plats are filed and subsequently monumented by others. Addressed also were problems associated with municipal agency requirements modifying "surveyor's certificates."

The final committee recommendations along with minority views were presented to PLSC Board of Directors November 30, 2006 at the Annual Membership meeting. Not all items listed above were included. In general, tradition and fundamentalism prevailed over vision and

reality in accepting and rejecting proposed legislative changes. The newly elected PLSC Board of Directors will meet to deliberate on the committee's proposal, including "Views of the Minority," and will approve, amend or reject as appropriate.

Ron Perkins served as Legislative Committee chairman until installation of new officers at the November 30 2006 Annual Membership meeting. President JB Guyton has since appointed Roger Nelson as chairman.

As of the end of the year, a legislative sponsor had not yet been obtained. Roger and others will be working with PLSC's lobbyist, Peg Ackerman, to assure a legislator will be retained to sponsor proposed legislation.

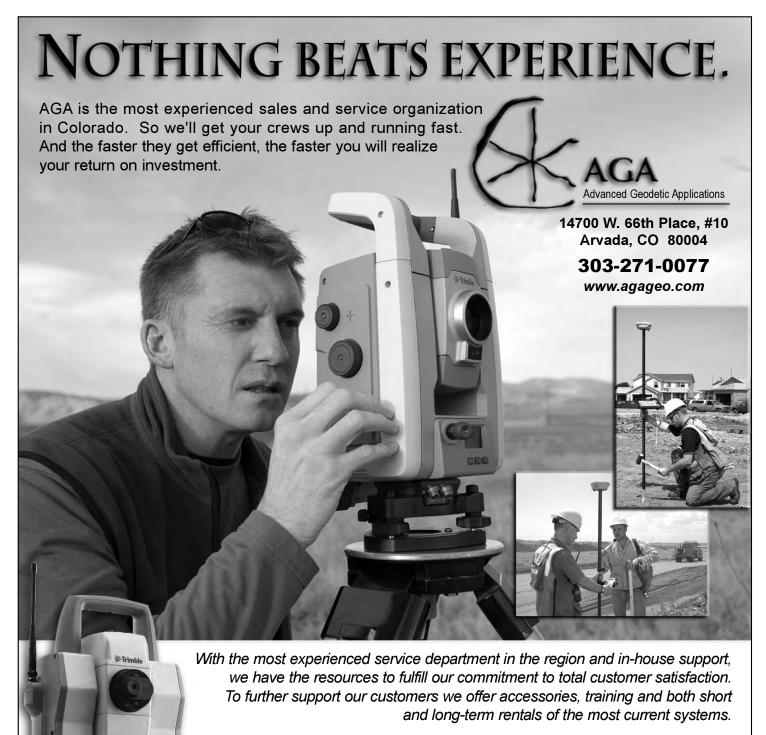

Voting Member — Any person who is a registered land surveyor in the State of Colorado, and whose registration is in full effect, shall upon payment of \$75 annual dues, be a voting member of P.L.S.C., Inc. and as such shall have full voting and office holding privileges. (Article IAI By-Laws)

Associate Member — Any person who is interested in land surveying shall, upon payment of \$55 annual dues, be an associate member of P.L.S.C., Inc., but shall have no voting or office holding privileges. (Article IA2 By-Laws)

Student Member — Any undergraduate student who is interested in land surveying shall, upon payment of \$15 annual dues, be a student member of P.L.S.C., Inc., but shall have no voting or office holding privileges. (Article 1A3 By-Laws) Individuals holding a Colorado PLS or PE-PLS registration are not eligible for this class of membership.

Retired Professional Land Surveyor — A Colorado licensed Professional Land Surveyor who no longer practices land surveying (including field work, office work and consulting). He/she however may continue to maintain his/ her license in effect and shall not be precluded from acting as an expert witness or court appointed commissioner. This is a non-voting classification. The annual dues shall be \$30.00.

Sustaining Member - Any person or firm engaged in a business related to land surveying or interested in the land surveying profession shall, upon contribution of \$200 annually, be a sustaining member of P.L.S.C., Inc., but shall have no voting or office holding privileges. (Article IA4 By-Laws)

Dues—Dues shall be due and payable as of January 1st for the coming year and shall be delinquent if not paid by April 1st following. Membership rights cease when dues become delinquent. (Article 1B By-Laws)

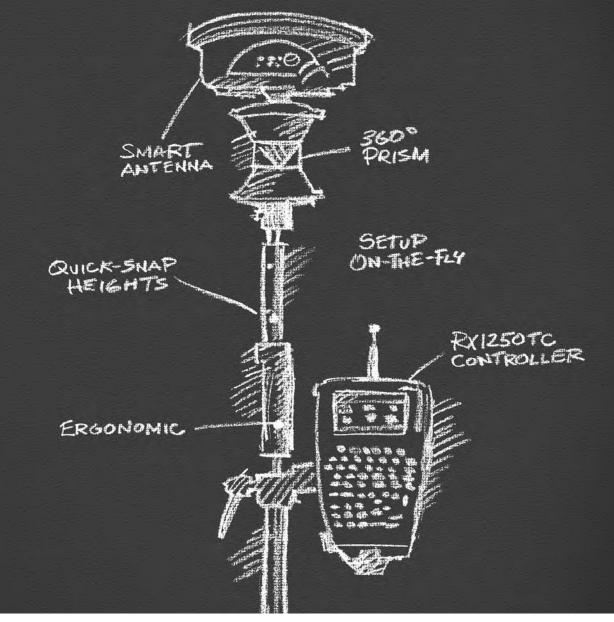

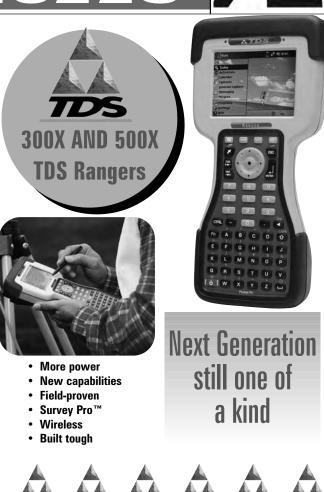

In Memorium

Seabron T. King

Seabron T. "Seab" King, age 91, passed away Sunday, January 7, 2007, at Delta County Memorial Hospital. He was born July 15, 1915 at Wellington, Texas, to Leslie Phillip and Modella Pearl (Price) King, the second of seven children. In 1918, the family moved to southeastern Colorado where they ranched and farmed near the small town of Kim, until 1933, when they moved to Paonia and settled on a farm on Lamborn Mesa. He graduated from Paonia High School in 1934. He worked at various jobs, mainly as a ranch hand, and in1937,



went to work for what was then know as the Grazing Service, now known as the Bureau of Land Management. Part of his job was to keep peace between the cattlemen and sheep men, and he also was a frequent spotter for planes during wild horse roundups.

On June 4, 1939, he married the former Margaret Elizabeth Sweet of Paonia. His work with the Grazing Service took them to various posts throughout western Colorado and Western Wyoming. Along the way they were blessed with two daughters, Elizabeth Ann (Betsy) Peterson and Virginia Louise (Ginni) Selby. Seab and Margaret were happily married for 61 years before her death in 2000.

In 1950, he received his license as a certified land surveyor, and went to work for the Soil Conservation Service in 1951 in Paonia. In 1958, he formed his own company and he was well known throughout western Colorado. He was a Charter Member of the Professional Land Surveyors of Colorado. He had served as their Vice President and also designed their logo.

He was an avid horseman and one of the founders of the North Fork Horse Patrol, which grew out of a horseback rescue he and the late Sy Gillenwater made of a U.S. Geological Survey crew. He and the late Phil Beaver built a small arena just south of where Paonia Care and Rehabilitation Center now stands so local kids could learn about horses and rodeos, and he was instrumental in building the present rodeo grounds west of Paonia. He was also partner with Sid Simpson in a packing and guide service for a number of years. One of his favorite quotes was "God forbid that I should go to any heaven in which there are no horses". He also loved the mountains and any time he could, he would slip away for a day's ride in the high country. He loved animals period, but had a special affinity for cats.

Mr. King was a member of the First Christian Church of Paonia and had been active until health prevented him from being active, but still served as an Honorary Trustee. He also served as Deacon, Trustee and was chairman of the church board for several years. He and his wife were active with the youth group while their daughters were growing up and later was the adult Sunday School teacher.

He was preceded in death by his parents, two brothers, Phillip and Lee, and one sister, Virginia. Besides his daughters, he is survived by a son-in-law, Roy Selby of Delta, two grandchildren, Thomas Wayne Kulm of Princeton, Indiana, and Melissa Ann Kulm of Evansville, Indiana, two great–granddaughters, Jazzlyn and Josephine Kulm of Winslow, Indiana, two sisters, Allene Gorby of Paonia and Dell Shelton of Uvalda, Texas, one brother Glen King of Hotchkiss, several nieces, nephews and cousins.

The practice of professional land surveying shall be deemed a privilege granted by the state of Colorado based on the qualifications of the individual as evidenced by such individual's licensing and registration. A LICENSEE MAY, SUBJECT TO ALL APPLICABLE STATE STATUTES. PRACTICE PROFESSIONAL LAND SURVEYING IN ANY COLORADO CITY, COUNTY, CITY AND COUN-TY, HOME RULE CITY, TOWN OR SPECIAL SERVICE DISTRICT. SUCH GOVERNMENTAL OR QUASI-GOVERNMENTAL ENTI-TIES SHALL NOT IMPOSE **REQUIREMENTS IN ADDITION TO** THOSE SET FORTH IN SAID STATE STATUTES, INCLUDING THIS PART 2, FOR THE PRAC-TICE OF PROFESSIONAL LAND SURVEYING WITHIN THEIR JURISDICTIONS.

Discussion was entertained and Peg Ackerman pointed out that this would face serious opposition and that it would not have any effect on Home Rule Cities. Warren Ward and Doyle Abrahamson expressed their opposition as a County Surveyor's.

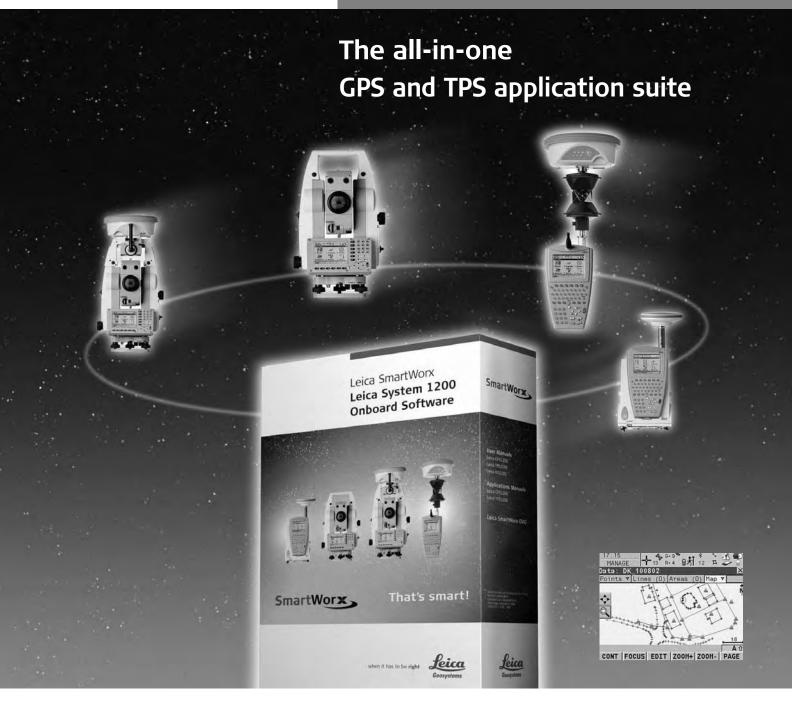

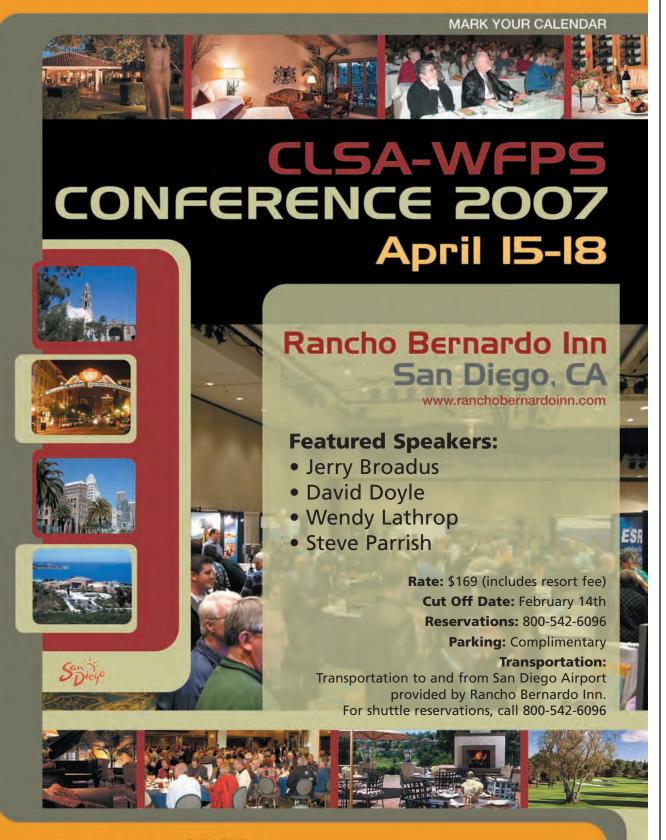

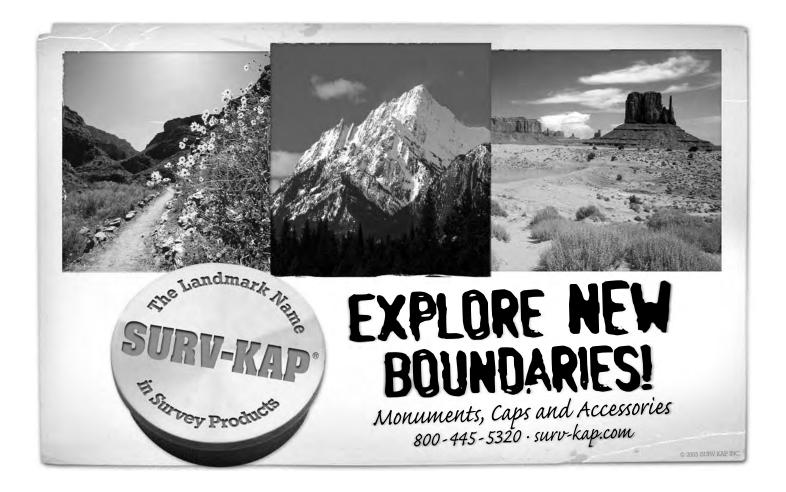
